## **Minutes of MSSS GBC Meeting**

Date of Meeting: March 24th, 2005. (6:00PM)

Place of Meeting: Sammie Riar's Office

Members Present: Charanjit Singh, Sammie Riar and Pritpal Bansal

Guests in Attendance: Rusty Norville, Civil Engineer, Chris Norton, Architect from Claude's office.

Pritpal presented the color rendering and the faced with elevations that he received from India. The Gurdwara looks very nice. Once the GBC and the guru sangat approve this plan, according Chris, Braganza Associates can incorporate this input in our final construction document. A set of drawing was given to all the attendees.

The adjusted construction document was presented by Chris Norton of Braganza Associates. Even though, we will use the kitchen as warm-up kitchen at the beginning, we must have all necessary provision for a commercial kitchen. The emphasis was on the provisions required on the locations and size of the drains, power outlets, locations for commercial equipment. Sammie and Chris will finalize the details for a proper commercial kitchen for eventual use.

We also reviewed and made changes to the electrical drawing. Data port and internet access point were added. Chris Norton stressed that he need the certificate from the department of health for the septic tank before we can get the building permit.

The site plan was presented by Rusty Norville of Civil Engineering Solutions. Rusty also presented the three quotes from the septic tank designers and suppliers. These three are:

1. Jack Matheny, Arlington, TN
2. Mid South Septic Service, Arlington, TN
3. Frankie Rowe Septic Service, Memphis, TN
4. We are waiting quote from A & J Septic Service, Cordova, TN

The quotes are \$15,800 to \$18, 800. This includes clearing of trees, design and city certificate and design and installations of low pressure pump, septic tank, field lines and the curtain.

It was agreed that we should engage one of the companies that can clear the trees and get us the certificate from the city for the building permit. We do not need to commit to the rest of septic tank project at this stage,

I met with Jack Matheny at the new Gurdwara site to understand the quote and the process earlier this week. The Church opposite to our site does not have a septic tank. Rusty will evaluate where they are hooked up for sewer.
